

WHEREAS, you have made an application for obtaining authorization for recycling of Copper mill scale and Iron mill scale at above site under the provisions of Hazardous & Other Wastes (M & TM) Rules 2016.

AND WHEREAS, as per the minutes of the 1st meeting of Authorization committee meeting held on 18/05/2022, as there is no SOP for manufacturing of Flux Powder. And even you have obtained only C to E for manufacturing of Flux Powder and till date not applied/ obtained C to O for the same. Committee recommended to issue final refusal as SOP is not prepared for Flux Powder by CPCB

NOW THEREFORE, as SOP is not prepared for Flux Powder by CPCB, your application for grant Authorization is hereby refused as per provision of under the Hazardous & Other wastes (Management and Tranboundary Movement) Rules 2016.

You may prefer on appeal against refusal order passed as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of this refusal order.
