WHEREAS, this office is in receipt of your application for grant of Consent Amendment Application Unique Number : MPCB-CONSENT_AMMENDMENT-0000019350 under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act,1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

As per Board's circular Dtd. 25/08/2025 amendment application shall be considered for typographical or clerical errors in the consent issued to the industry and change in the name of the industry and change in disposal path of hazardous waste for pre-processing or co-processing only. Your application do not fit for grant of amendment as per MPCB circular Dtd.25/08/2025.
