Sub: Refusal of Consent to Operate under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981.

WHEREAS, this office is in receipt of your application for grant of Consent to Establish under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board office has issued letter vide reference (2) above in which asked to submit the information regarding such as water budget use for hospital activity also not submitted water bill or details of source of water. Also not provided STP plant for treatment of effluent generation from hospital activity. The generation of bio medical waste with category also not submitted details. HCE has submitted CA certificate of Rs.35.50 lacs they have not submitted CA certificate without depreciation value. scrutiny letter issued to HCE regarding submission of details of water budget. BMW categories with quantity of waste, details of STP plant with design details. You have not submitted previous consent consent /BMW authorization copy. You have operating your HCE without valid authorization/consent & STP from 2013. you have not submitted clarification for the same

AND WHEREAS, you have failed to submit the reply to the letter even sufficient & reasonable opportunity given for the submission of same and in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
