
- 5.** This Authorisation is granted as per the provisions under section 13 (2) (c) of the of Hazardous & Other Waste (Management and Transboundary Movement) Rules, 2016.
- 6.** This authorisation is subject to the following general and specific conditions:

### A. General conditions of authorisation:

- 1.** The authorised person shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
- 2.** The authorisation shall be produced for inspection at the request of an officer authorised by the State Pollution Control Board.
- 3.** The person authorised shall not import, store and trade in the Other wastes other than those wastes permitted through this authorisation.
- 4.** Any change in the storage location shall be reported to the State Pollution Control Board.
- 5.** The authorised person shall intimate the State Pollution Control Board regarding closure of the facility.
- 6.** The waste which gets generated during storage and trading of imported Other wastes shall be treated and disposed of as per prevailing regulations.

7. The importer shall bear the cost of import and mitigation of damages if any caused during the process of import, storage and trading.
8. Any other conditions for compliance as per the Guidelines issued by the Ministry of Environment, Forest and Climate Change or Central Pollution Control Board from time to time.
9. Annual return as per Form IV shall be filed by June 30th for the period ensuring 31st March of the year.
10. The Authorised Trader shall be responsible to obtain other statutory permissions as may be required.
11. Actual Recycler shall mark on the Finished Goods that ' The finished Goods is made up from Waste Scrap .
12. Custom Department alongwith the MPCB Officials should verify the imported Waste / Scrap for category / quality with one time Authorisation issued by the MPC Board before releasing the consignment.
