Sub: Refusal of Consent to Operate u/s of the Water (Prevention & Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 10(2) of the Bio-Medical Wastes Management Rules, 2016.

- Ref: 1. Your applications for grant of authorization (22710) under the provisions of the Bio-Medical Waste Management Rules, 2016 received from Sub-Regional Office, Thane-II.  
2. Show Cause Notice issued by this office on 17/07/2020.

**WHEREAS**, the Ministry of Environment and Forests, Govt. of India in exercise of the powers conferred by section 6,8 and 25 of the Environment (Protection) Act, 1986 has notified the Bio-Medical Waste Management Rules, 2016 for proper management and handling of the Bio-Medical Waste.

**AND WHEREAS**, you have made an application for grant of Consent to Operate under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 & the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Bio-Medical Wastes Management Rules, 2016.


**AND WHEREAS**, after scrutiny of your applications, it was observed that you have failed to submit required documents & fees, which was brought to your notice vide show cause notice for refusal issued on 17/07/2020 and was instructed to submit the reply within seven days.

**AND WHEREAS**, despite of issuance show cause notice, you have failed to submit the required documents and requisite fees of Rs.7500/-. This shows your negligence attitude towards the implementation of the Environmental Laws.

In view of the aforesaid non-compliance on your part, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 10(2) of the Bio-Medical Waste Management Rules, 2016.

If you are aggrieved with the said Refusal of authorization/Consent, you may prefer an Appeal under Section 28 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 31 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 16(1) of the Bio-Medical Waste Management Rules, 2016 before the Secretary, Environment Department, Govt. of Maharashtra, within a period of 30 days from the date of receipt of the said letter.

Your reply, to the above point shall reach this office within 15 days of the receipt of this Notice, failing which the Board shall initiate appropriate legal action including prosecution against you, which please note.
