WHEREAS, this office is in receipt of your application for grant of Consent to Establish under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016. The Sub Regional Officer's Latur had reported that you have applied for consent to establish for expansion vide UAN No. MPCB-CONSENT-0000272916 for the production of Ice Cream- 900 Lit/day. Instructed for submission of Clarification for submission application for amendment vide letter dtd. 27.01.2026

AND WHEREAS, AND WHEREAS, As per Board Circular dated 25.08.2025 you case cannot be consider for expansion in product quantity hence your Amm dement consent application hereby refused

AND WHEREAS, you have failed to submit the reply to the letter even sufficient & reasonable opportunity given for the submission of same and in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
