Sub: Refusal of Amendment in Consent to Operate under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981.

WHEREAS, this office is in receipt of your application for grant of Amendment Consent to Operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, as per MPC Board's circular dated 25/08/2025, amendment in consent can be considered only for - (a) Typographical or clerical errors in the consent issued to the industry (b) Change in Name of industry (c) Change in disposal path of Hazardous Waste for pre-processing or co-processing, as per the policy of the Board. However, you have applied for the amendment seeking following changes in the existing Consent to Operate (Par-II) -

1. Incorporation/ increase of the validity period of the Consent to Operate for five years.
2. Addition of Hazardous Waste Category 37.3 - Concentration or Evaporation Residues: 1746 MT/A.
3. Revision in non-hazardous waste generation quantities.

AND WHEREAS, your application for amendment in consent can not be considered as the changes sought in the application does not comply with the MPC Board's above referred circular.

In view of above, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
