- The applicant shall strictly comply with the circular issued by the Board vide No. MPCB / JD(APC) / NACP / DG Set / B-0090 dtd. 02/06/2023 regarding Retrofitting of Emission Control Device (RECD) for in-use Diesel Operated Internal Combustion Engines / D.G. Sets.
- The applicant shall obtain necessary permission from the Directorate of Industrial Safety and Health (DISH), in case of store /handle/ process the Hazardous Chemicals.
- The applicant shall not manufacture / carried out any products / activities, which attract Environmental Clearance as per EIA Notification, 2006 and amendments thereto.
- The applicant shall not manufacture banned products as per Govt. Authorities and Agriculture Department.
