WHEREAS, this office is in receipt of your application for grant of Consent to Establish under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board office has issued scrutiny letter & SCN for refusal of consent vide reference (2 & 3) regarding shortcomings in application above in which asked to submit the information regarding submission of proper water budget, STP details, category & quantity of BMW, self attested undertaking on letter stating date of commissioning, total plot area, build up area, and non applicability EC, quantity of effluent arising from pathology, land ownership certificate, membership certificate of CHWTSDF, Registration under BNH, online submission of BMW annual report & to pay additional consent fees of Rs. 1, 22,500/-.

AND WHEREAS, you have failed to submit the reply to the letter even sufficient & reasonable opportunity given for the submission of same and in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
