Ministry of Environment, Forest & Climate Change (MoEF & CC) has notified Plastic Waste Management Rules, 2016, in exercise of the powers conferred under sections 3, 6 & 25 of the Environment (Protection) Act, 1986 vide Notification No. G.S.R 320 (E) dated March 18, 2016.

**Guidelines on Extended Producer Responsibility for Plastic Packaging were notified by MoEF & CC on February 16, 2022 in Schedule - II of 4th amendment of Plastic Waste Management Rules, 2016.** As per section 6.1(a) of the above Guidelines, "The following entities shall register on the centralized portal developed by Central Pollution Control Board namely: - (i) Producer (P); (ii) Importer (I); (iii) Brand owner (BO); (iv) Plastic Waste Processor (PWP) engaged in (a) recycling, (b) waste to energy, (c) waste to oil, and (iv) industrial composting.

SOP for EPR has been developed and uploaded on CPCB EPR Portal. The EPR Portal is available at following link:- <https://eprplastic.cpcb.gov.in/#/plastic/login/admin>

Hence, you are instructed to submit the application for EPR on the URL given above. Failure to this, the Board will initiate further legal action under the provision of the water (Prevention & Control of pollution) act, 1974 and section 21 of the Air (Prevention and control of Pollution) act, 1981 against you, which please be noted.

Therefore, your application is returned for resubmission in EPR Format on CPCB online portal as per applicability. If you have already obtained EPR, please ignore this letter.
