WHEREAS, you have made an application in form no. 1 for obtaining authorization for E-waste dismantler under the provisions of E-Waste Rule 2016.

AND WHEREAS, the application was discussed in 38th Meeting of Authorization Committee for environmental sound Management of Hazardous & Other Wastes & E-Waste held on 30/01/2020. The industry representative has failed to attend 38th committee meeting. After due deliberation, Committee recommended to issue refusal of application for Consent to Operate and authorization as PP could not attend the 38th meeting.
