WHEREAS, this office is in receipt of your application for grant of Consent to Amendment under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, Board has granted Consent to Operate on 24/12/2025 for the mfg. of PAPAD (Food Product) -1500 Kg/M valid upto 31.12.2028 for Rs.0.6 Crs. i.e. for 60 lacs. vide reference (1) above and you have applied for amendment for change in capital investment as CI of Rs. 60 Lacs.

AND WHEREAS, as consent to operate was already granted. The Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Amendment is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
