Ref:- Your online application received vide MPCB-HW_AUTH-0000001339 and MPCB-HW_AUTH-0000001337 i.e. two applications received under Hazardous waste generator or transporter.

You are aware that, your unit is located in the "Pollution Prevention Area" under the Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 followed by further amendments made therein from time to time. And it is obligatory on your part to obtain prior Consent to Establish and Operate of the Board and to provide adequate water and air pollution control systems to control the pollution from your activity.

It is mandatory on your part to apply for obtaining Consent to Establish before starting construction activity and shall obtain prior Consent to Operate before starting Commercial manufacturing / production. It is observed during the visit of Board Officials that your activity is found in operation without obtaining Consent to Establish / Operate from Maharashtra Pollution Control Board. Accordingly, Board Office had issued Closure Direction against the industry vide C.D. Notice No. 1103 dated 09.08.2019. You are directed not to start the commercial activity without obtaining prior Consent to Establish / Operate and restart direction from the Board failing which Board Office will initiate further suitable legal action against the industry.

Recently, you had applied online applications (02 nos) for Grant / Renewal Of Authorization For Generation Or Collection Or Storage Or Transport Or Reception Or Recycling Or Reuse Or Recovery Or Preprocessing Or Co-Processing Or Utilization Or Treatment Or Disposal Of Hazardous And Other Waste vide above reference (1) and during the scrutiny of the said application it was observed that you have submitted application in Hazardous Waste generating units for Authorization instead of fresh online consent to 1st Operate application.

Due to non-receipt of proper Consent to 1st Operate online application this office is unable to process your application form, therefore, you are instructed to resubmit fresh online application alongwith required documents and requisite fees. However, your application is disposed off herewith under the provisions of Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention
