WHEREAS, you have made an application in form no. 1 for obtaining authorization for recycling/reprocessing of Spent Solvent under the provisions of Hazardous & Other Wastes (M & TM) Rules 2016.

WHEREAS, the Central Government has notified the Hazardous and Other Wastes Management and Transboundary Movement) Rules, 2016 in supersession of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008 for safe and environmentally sound management of hazardous and other wastes.

AND WHEREAS, as per the Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016, it is obligatory on your part to obtain the Authorisation from the State Pollution Control Board for processing, recycling and recovery of hazardous waste.

.AND WHEREAS, the CPCB has prepared a standard operating procedures and minimal requisite facility for the utilization of spent solvent (generated from industrial uses of solvents, production/industrial use of synthetic dyes, dye intermediates and pigments, production/formulation of drugs/pharmaceutical and health care product; and production and formulation of pesticides including stock-piles) to recover solvents/mixed solvents for industrial use. Only upon verification and compliance of provisions & minimal requisite facilities outlined in the said SOPs authorization will be granted by MPCB.

Your application was discussed in 28, 29, 32, and 35 the Meeting of Authorization Committee for environmental sound Management of Hazardous & Other Wastes & E-Waste. Committed noted that you have not provided adequate facility for distillation of mixed /spent solvent also you are could not attained the said meetings. Therefore, Committee recommended to issue final refusal of application for authorization.

NOW THEREFORE, your application for grant Authorization is hereby refused as per provision of under the Hazardous & Other wastes (Management and Tranboundary Movement) Rules 2016.

You may prefer on appeal against refusal order passed as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of this refusal order.
