WHEREAS, this office is in receipt of your application for grant of Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board office has issued show cause notice vide reference (2) above for non-submission of compliance as per the SOPs prescribed by CPCB for reconditioning and cleaning of barrels and PVC carboy and not providing ZLD system for treating the effluent. You have failed to submit desired information despite of the sufficient and reasonable opportunity given for the submission of the same.

AND WHEREAS, in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
