WHEREAS, this office is in receipt of your application for grant of Amendment in Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board office has issued Consent to Operate vide reference (2) for Aluminium Diacasting With Machining- 125 MT/M. Now you have applied for Amendment in existing Consent to Operate with enhancement of production capacity- 230 MT/M. It is required to apply regular application for Consent.
