WHEREAS, this office is in receipt of your application for grant of Amendment in Consent to Operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, it is observed that the present application is a duplicate application, as you have also submitted two separate applications for amendment of the same consent vide UAN Nos. MPCB-CONSENT_AMENDMENT-0000020519 and MPCB-CONSENT_AMENDMENT-0000020520.

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981.
