WHEREAS, this office is in receipt of your application for grant of amendment in Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board has issued Proposed Direction on 16.01.2026 for various non-compliance of RMC guidelines circular dtd 17.10.2025. Industry has attended personal hearing extended on 23.01.2026.

AND WHEREAS, You are directed to apply for consent through the regular consent application process with payment of appropriate consent fees, as per the application norms.

In view of above, your application for grant of amendment in Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981. You are hereby directed not to take any effective steps towards operation of the unit without permission of the Board, else Board will initiate legal action as per the provisions of Environmental enactments.

If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
