WHEREAS, this office is in receipt of your application for grant of Consent to Operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, this office has issued show cause notice vide above reference (2) as to submit justification for operation of pathology without obtaining CCA, submission of land and building cost for to calculate penal charges and consent fees, water budget, treatment facility and permission of Pimpri Chinchwad Municipal Corporation.

AND WHEREAS, You have submitted only membership of CBMWTFD and you have not submitted point wise reply of Show Cause Notice with land and building cost. Considering this, you have submitted reply which is not satisfactory as failed to submit detailed land and building cost, permission of PCMC.

In view of above, considering the above noncompliance, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981. You are hereby directed not to take any effective steps towards operation of the unit without permission of the Board, else Board will initiate legal action as per the provisions of Environmental enactments. If you are aggrieved by this order, you may prefer on appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 days' time from the date of receipt of this letter. Please note that Establish/Operate of the industry without valid consent of the Board is an offence and attracts further stringent legal action as deem fit under the provision of various Environmental enactments, which may please be noted.
