Grant of Amendment in Consent to Operate under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 6 and Rule 18(7) of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules 2016 is considered and the amendment in consent is hereby granted subject to the following terms and conditions and as detailed in the schedule I, II, III & IV annexed to this order:

1. Following Amendment in Existing Consent :

| 1       | The industry shall obtain MIDC permissions as MIDC transfer order/Subletting permissions towards textile activity within 30 days and shall submit Bank Guarantee of Rs.10000/-. Also, industry shall not take any effective steps towards establishment activity without obtaining MIDC permissions such as MIDC transfer order/subletting permissions towards textile activity. | The industry shall carry out manufacturing activity as mentioned in MIDC letter or MIDC subletting agreement. |

- The Board reserves the right to review, amend, suspend, revoke this consent and the same shall be binding on the industry.
- This consent should not be construed as exemption from obtaining necessary NOC/permission from any other Government authorities.
- The industry shall ensure that total built up area shall not exceed 20,000 sq. m i.e. Building and construction of the project shall not be more than 20,000 sq. m.
- The industry shall provide Sewage Treatment Plant as per CPCB guidelines.
- The industry shall obtain necessary permission from the Central Ground Water Authority (CGWA) regarding the use of ground water.

7. The industry shall obtain necessary permission from the Directorate of Industrial Safety and Health (DISH).
8. The industry shall strictly follow Maharashtra Plastic and Thermocol Products (Manufacture, Usage, Sale, Transport, Handling and Storage) Notification, 2018 and amendment thereto.
9. The industry shall provide necessary equipment's to all dust generating sources to ensure that Total Particulate Matter not to exceed 150 mg/Nm<sup>3</sup>.
10. This consent should not be construed as an exemption for issues related to land ownership / land lease agreement / partnership agreement.
11. The applicant / industry shall not carry out expansion of the industry without prior permission of the Board.
12. The industry shall carry out manufacturing activity as mentioned in MIDC letter or MIDC sub-letting agreement.
13. The applicant shall obtain Consent to Operate from Maharashtra Pollution Control Board before actual commencement of the Unit/Activity. (Establish)

This consent is issued on the basis of information/documents submitted by the Applicant/Project Proponent, if it has been observed that the information submitted by the Applicant/Project Proponent is false, misleading or fraudulent, the Board reserves its right to revoke the consent & further legal action will be initiated against the Applicant/Project Proponent.
