 You have operating manufacturing (phosphating & spray painting) activity since from 01.06.2017 without obtaining consent to establish and operate of MPCB.

You have not submitted detailed water budget, generation of trade effluent and treatment and disposal details of trade effluent.

3. You have not provided air pollution control system to acid pickling & phosphating activity.

As per application form CI is Rs. 3.74 Crs but submitted CA certificate showing CI Rs. 2.49

5. You have not submitted plot allotment / plot subletting letter of concern MIDC authority.

ANDWHEREAS, for above non-compliances vide letter no. BO/JD (APC)/SCN/TB-2-2718 dtd. 24/07/2018 Board has issued show cause notice. Same was uploaded on web portal 7 also through email and directed to submit your reply. But till date you have not submitted reply.
