- **6.** This authorisation is subject to the following general and specific conditions:

#### A. General conditions of authorisation:

- 1. The authorised person shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
- 2. The authorisation shall be produced for inspection at the request of an officer authorised by the State Pollution Control Board.
- **3.** The person authorised shall not import, store and trade in the Other wastes other than those wastes permitted through this authorisation.
- **4.** Any change in the storage location shall be reported to the State Pollution Control Board.
- **5.** The authorised person shall intimate the State Pollution Control Board regarding closure of the facility.
- **6.** The waste which gets generated during storage and trading of imported Other wastes shall be treated and disposed of as per prevailing regulations.
- 7. The importer shall bear the cost of import and mitigation of damages if any caused during the process of import, storage and trading.
- **8.** Any other conditions for compliance as per the Guidelines issued by the Ministry of Environment, Forest and Climate Change or Central Pollution Control Board from time to time.
- **9.** Annual return as per Form IV shall be filed by June 30th for the period ensuring 31st March of the year.
- **10.** The Authorised Trader shall be responsible to obtain other statutory permissions as may be required.
- **11.** Actual Recycler shall mark on the Finished Goods that ' The finished Goods is made up from Waste Scrap .
- **12.** Custom Department alongwith the MPCB Officials should verify the imported Waste / Scrap for category / quality with one time Authorisation issued by the MPC Board before releasing the consignment.
