


WHEREAS, you have applied for grant of Authorization for import of Nylon, Polyester, PET, PVC, PP-60 MTA (Part-D of Schedule-III) for trading activity under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board has issued SCN for refusal vide reference (3) above in which asked to submit the following details :

- 3) Submit details of specific type of scrap.

AND WHEREAS, you have failed to submit the satisfactory reply to the Show Cause Notice for refusal even sufficient & reasonable opportunity given for the submission of the same and in the absence of the desired information, the Board is unable to take decision about grant of authorization.

NOW THEREFORE, your application for grant of Authorization is hereby refused under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 for the above non-compliances.
