AND WHEREAS, Board office has issued letter vide reference (2) above due to non-submission of details of EC as per consent to establish granted vide dated 10.09.2024 to Nathan Properties CA to Owners, clarification towards name of unit as application is in name of CRAFT DE SRISHTI & agreement, udaym registration is in name of Raunak Enterprises & details of land documents wherein proposed RMC plant will be installed.

AND WHEREAS, you have failed to submit the reply/any say to the Show Cause Notice even sufficient & reasonable opportunity given for the submission of same and in the absence of the desired information, the Board is unable to take decision about grant of consent.
