WHEREAS, this office is in receipt of your application for grant of Combined Consent to Establish under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Bio Medical Waste Rules, 2016.

AND WHEREAS, Board office has issued letter vide reference (2) above in which asked to submit the information regarding not paid Authorization fee Rs. 11250.00/-not paid additional fees of Rs. 50000/-, and not paid penal charges Rs.228497.00/-

AND WHEREAS, you have failed to pay additional consent fee, Authorization fee and penal charges even sufficient & reasonable opportunity given for the submission of same and in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of combine Consent to Establish and Authorisation under BMW Rules 2016 is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
