



WHEREAS, you have made an application for obtaining authorization for for Recovery of Bromine from Sodium Bromide, Potassium Bromide, Ammonium Bromide, Hydrobromic Acid under the provisions of Hazardous & Other Wastes (M & TM) Rules 2016.
