AND WHEREAS, Board has received your application for “The vehicle number **AP27X2599, TSO7UF6125, KA28B2519, KA63A2757, KA28B2559** for grant of Authorisation for Hazardous waste Transportation under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.
