At the outset, we are thankful to you for processing bio-medical waste authorization (One Time Authorization) / Combined Consent and Bio-Medical Waste Authorization (CCA) UAN No. MPCB-BMW\_AUTH-0000025131 (**Please refer as Annexure-7**).

It may please be noted that, we had been granted bio-medical waste authorization earlier (**Please refer as Annexure-1 & 4**). Further we had submitted amendment applications under the Bio-Medical Waste Management Rules, 2016 as per **Annexure-2 & 3**. Subsequently we had applied for renewal of bio-medical waste authorization having

application UAN No. MPCB-BMW\_AUTH-0000023400 dated 12.07.2019 as per  
**Annexure-5.**

In these applications, we had requested for change in category numbers of bio medical waste as per BMW rules generated from the Occupational Health Centre (OHC) located at factory premises having 04 nos. of beds. These beds were used during routine medical tests of employees (such as ECG, blood test, etc.) and first aid.

Now, CAC committee has directed to obtain one-time authorization for the industries having OHC as first-Aid centre, operated on need basis and shall require to apply online for obtaining one time permission under non-bedded category, under the BMW rules.


