WHEREAS, this office is in receipt of your application for grant of authorization under Bio-Medical Waste Management Rules, 2016 as amended.

AND WHEREAS, MPC Board have granted Consent cum BMW Authorization (CCA) to your HCE as per provisions of the section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Bio-Medical Waste Management Rules, 2016 as amended & for the address as mentioned above vide referred letter at Sr. No. 2.

AND WHEREAS, It is brought to your notice that there is no provision of issuance of dual Consent cum BMW Authorization (CCA) for a single legal entity at the same place. Further, The CCA granted to your HCE at address mentioned as above is valid up to 31/05/2024. So new CCA/ renewal of CCA of the said HCE cannot be processed before expiry of the said authorization.

In view of above, your application for grant of authorization under Bio-Medical Waste Management Rules, 2016 vide above referred letter at sr. no. 1 is hereby refused.

If you are aggrieved by this order, you may prefer on appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 days' time from the date of receipt of this letter.
