1. The authorization shall be in the force for one year disposal from date of issue of authorization.
2. The authorization is subject to the conditions stated below and sub conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

TERMS AND CONDITIONS OF AUTHORISATION

1. The authorization shall comply with provisions of the Environment (Protection) Act, 1986 and the Rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the Maharashtra Pollution Control Board.
3. The person authorized shall not rent, land, sell, transfer or otherwise transport the hazardous wastes without obtaining prior permission of the Maharashtra Pollution Control Board.
4. Any unauthorized change in personnel, equipment or working conditions as mentioned in the application by the person authorized shall continue a breach of the authorization.
5. It is a duty of the authorized person to take prior permission of the Maharashtra Pollution Control Board.
6. An application for the renewal of an authorization shall be made as laid down in Rule 5 (6) (II) of Hazardous Wastes (Management, Handling & Trans boundary movement) Rules, 2008.
7. The unit shall follow manifest system as per Rules 7 (4) and shall transport with Authorized Hazardous Waste Transporter.
8. The Storage and disposal of hazardous waste shall be done within 90 days.
9. The unit shall maintain all necessary records and submit to this office along with copy to concern Sub-Regional Officer of the Board.
10. The storage areas shall be in accordance with provisions of Rule.
11. The unit shall follow the guidelines of storage of hazardous waste as per Hazardous Waste (Management, Handling & Tranboundary Movement) Rules, 2008 and guidelines issued by CPCB time to time.
12. Hazardous waste shall be transported only through MPCB authorized hazardous waste transporter.
13. Whenever due to any accident or other unforeseen act is apprehended to occur, such information shall be for with reported to Board, concerned Police Station, office of Directorate of Heath Services, Department of Explosives, Inspectorate of Factories and Local Body.
14. This authorization does not absolve to the unit to obtain any other statutory clearances/NOC/license as required from various Govt. bodies.
