WHEREAS, you have made an application in form no. 1 for obtaining authorization for recovery of precious metal i.e gold, silver, platinum, palladium & rhodium from STP Sludge through Septic Tank, Gutter waste & dust. 35 Kg/M. under the provisions of Hazardous & Other Wastes (M & TM) Rules 2016.

AND WHEREAS, the said application was discussed in the 3rd authorization committee meeting (2nd sitting) held on dtd. 20/09/2024 and Committee noted that PP has not required HW Auth under rule 9 for recovery of metal from STP, septic tank sludge. Hence, Committee decided to reject the application.

NOW THEREFORE, your application for grant Authorization is hereby refused as per MoM of the said Meeting under the Hazardous & Other wastes (Management and Transboundary Movement) Rules 2016.

You may prefer to an appeal in Form 12 under provisions of Rule 24 of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 to the Appellate Authority, against refusal order passed as per provision under Section 6(4) of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of this refusal order.
