
WHEREAS, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for recycling of Plastic waste vide reference No.1.

AND WHEREAS, as per sub-rule 7 of the rule 13 of the Plastic Waste Management Rules, 2016, "On receipt of the application complete in all respects for the registration for recycling or processing of plastic waste under sub-rule (3), the State Pollution Control Board may, after such inquiry as it considers necessary and on being satisfied that the applicant possesses appropriate facilities, technical capabilities and equipment to handle plastic waste safely, may grant registration to the applicant on fulfilment of the conditions as may be laid down in terms of registration."

AND WHEREAS, during scrutiny of your application certain lacunae were observed and accordingly, Show Cause Notice for cancellation of your application was issued vide ref. no. 2 as you have obtained only Consent to Establish dtd 21.9.2020 but not Consent to Operate and the address in MSME registration mentions location of your unit as Goregaon (east) whereas the application of registration and consent to establish mentions site address as Vasai (east) Palghar.

AND WHEREAS, you have failed to submit reply to the Show Cause Notice which shows your negligent attitude towards compliance of Environmental norms.

In view of the aforesaid, your application for grant of registration as Recycler is hereby cancelled / not considered by Maharashtra Pollution Control Board under the provisions of the Plastic waste Management Rules, 2016.
