WHEREAS, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for recycling of Plastic waste vide reference No.1.

AND WHEREAS, Board has granted your unit registration under PWM rules, 2016 for mfg of Reprocessed Plastic chips and Granules from Plastic Waste 30 MT/M with condition to prepare and submit annual report of plastic waste processing or recycling in Form-IV to the local body concerned under intimation to the concerned State Pollution Control Board or Pollution Control Committee by the 30th April, of every year.

AND WHEREAS, Board has already issued Show Cause Notice vide ref. no.3. for following non-compliances observed during scrutiny of your application for registration.

1. You have not submitted copy of Annual report for the year 2020-21 of plastic waste processing or recycling in Form-IV submitted to the local body, alongwith the application of renewal of registration, as prescribed in previous registration.

AND WHEREAS, you have failed to submit reply to the Show Cause Notice.

In view of the aforesaid, your application for grant of registration as Recycler is hereby cancelled / not considered by Maharashtra Pollution Control Board under the provisions of the Plastic waste Management Rules, 2016 and further you are directed not to operate the unit without obtaining prior Consent to Operate and registration from the Board, failing which stringent action may be initiated against the unit, which may please be noted.
