WHEREAS, Ministry of Environment and Forests, Govt. of India has notified, Water (Prevention and Control of Pollution), Act, 1974 for prevention and control of water pollution and the maintaining or restoring of wholesomeness of water and Air (Prevention and Control of Pollution), Act, 1981 for prevention, control and abatement of air pollution.

AND WHEREAS, Central Pollution Control Board on 04.06.2014 has issued Directions under section 18 (1) (b) of Water (Prevention and control of Pollution) Act, 1974 regarding classification of Industries into Red, Orange and Green in which Health Care Establishment are covered under the regime of Consent.

AND WHEREAS, Ministry of Environment and Forests, Govt. of India in exercise of the powers conferred u/s. 6,8 & 25 of Environment (Protection) Act, 1986 has notified the Bio-Medical Waste Management Rules, 2016, and amended Rules, 2018 which is subsequently amended from time to time.

AND WHEREAS, Maharashtra Pollution Control Board is the Prescribed Authority for the enforcement of Bio-Medical Waste Management Rules, 2016, as amended from time to time.

AND WHEREAS, it is also obligatory on the part of every occupier generating biomedical waste to obtain Consent to Operate and BMW authorization under Rule 8 of the said Rules, by making application in Form-II to the prescribed authority accompanied by a fee as prescribed by the Government of Maharashtra.

AND WHEREAS, this office is in receipt of your application for grant of Consent to operate and BMW Authorization from SRO Sangli on 17/12/2021. Upon Scrutiny SCN for PTO...

Refusal issued to you on 02/02/2022, wherein it was brought to your notice to submit Documents / Information, for considering CCA.

AND WHEREAS, you failed to submit compliance to the SCN for refusal within time, therefore Personal Hearing before Principal Scientific Officer, MPCB was extend to you on 08/03/2022 at 3.00 P.M. through Video Conference, in which you were Compliance of SNC for refusal within time.

AND WHEREAS, it is noted that, inspite of efforts taken by Board you have failed to submit the Following required Documents / Information / fees to consider your application for grant of CCA.

- 1. Additional Consent fee as per revised CI cost (ref point 1)
- You were operating HCE without Valid CCA from 04/06/2019, hence Delay Payment charge as per revised CA certificate of INR 1,68,288/- Not paid.
- Category and Quantity of BMW generation in Kg/month as per Schedule-I of BMW Management Rules, 2016.
- 4. Not having separate BMW storage area, as per CPCB guidelines
- 5. Revised Water Budget, Water Bills for last six Months.
- 6. Bifurcation of Water use between Borewell and Nagarparishad supply.
- 7. NOC From CGWA or Acknowledgment copy of Application made to CGWA.
- 8. Details of Laboratory Waste Pre-treatment Equipment as per BMWM Rules, 2016.
- 9. Details (Schematic & Photographs) of STP & ETP alongwith adequacy report.

AND WHEREAS, this shows your negligent attitude towards implementation of Bio-Medical waste Management Rules, 2016.

NOW THEREFORE, in exercise of the powers conferred upon me, In view of the aforesaid non-compliances on your part, your Application for Consent To Establish is hereby stands Rejected under the provision of Section 25 (4) of Water (P & CP) Act, 1974 and Section 21 (4) of Air (P & CP) Act, 1981 and under Rule 10(2) of Bio-Medical Waste Management Rules, 2016.

If you are aggrieved with the said Refusal of your application for Combined Consent and BMW Authorization, you may make an Appeal under Section 28 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 31 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 16(1) of the Bio-Medical Waste Management Rules, 2016 before the Principal Secretary, Department of Environment & Climate Change, Govt. of Maharashtra, within a period of 30 days from the date of receipt of this order.
