

WHEREAS, you have made an application in form no. 1 for obtaining authorization & consent to operate for recycling/reprocessing of Reconditioning and washing of contaminated drums/ barrels under the provisions of Hazardous & Other Wastes (M & TM) Rules 2016.

Your application was discussed in 32nd Meeting of Authorization Committee for environmental sound Management of Hazardous & Other Wastes & E-Waste held on 22/01/2019. Committed noted that you have not replied SCN issued 15/11/2018 as you have not provided adequate facility as per SOPs also you could not attend the said meeting. Therefore, Committee recommended to issue final refusal of application for authorization.

NOW THEREFORE, your application for grant Authorization & consent is hereby refused as per provision of under the Hazardous & Other wastes (Management and Tranboundary Movement) Rules 2016.
