**WHEREAS**, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for recycling of Plastic waste vide reference No.1.

**AND WHEREAS**, Board has granted your unit registration under PWM rules, 2016 for mfg of REPROCESSING OF PLASTIC WASTE INTO GRANULES -310 MT/M with condition to prepare and submit annual report of plastic waste processing or recycling in Form-IV to the local body concerned under intimation to the concerned State Pollution Control Board or Pollution Control Committee by the 30th April, of every year.

**AND WHEREAS**, Board has already issued Show Cause Notice vide ref. no.3. as you have not submitted annual report of plastic waste processing or recycling in Form-IV to the local body concerned under intimation to Maharashtra Pollution Control Board.

**AND WHEREAS**, you have failed to submit reply to SCN even after lapse of considerable time period.

In view of the aforesaid, your application for grant of registration as Recycler is hereby cancelled / not considered by Maharashtra Pollution Control Board under the provisions of the Plastic waste Management Rules, 2016 and you are hereby directed re-apply and not to carry out operation activities without obtaining registration, failing which the Board will have no option then to initiate further legal action against you, which please note.
