WHEREAS, your unit is located in the "Pollution Prevention Area" under the Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention under Bio-Medical Waste (Management and Handling) Rule, 1998. & Control of Pollution) Act, 1981 and Authorization under the Hazardous and Other Wastes (M & TM) Rules, 2016 followed by further amendments made therein from time to time. And it is obligatory on your part obtain consent of the Board and to provide adequate air and water pollution control systems to control the pollution from your activity.

AND WHEREAS, you had applied for grant of authorisation vide above reference (1) and Sub-Regional Officer has processed and submitted the said application to this office with non-compliances/discrepancies in the application as follows.

1. You have not obtained CHWTSDF membership of BMW management facility allotted for your hospital jurisdiction.
2. You have not submitted BMW disposal details.
3. You have not submitted annual report regarding BMW generated at your hospital.

AND WHEREAS, it is noted that, after communication and given sufficient time period, you have failed to submit your compliance and reply to above notices which shows your negligent attitude towards compliance of Provision of the Water (P& CP) Act, 1974 and the Air (P& CP) Act, 1981 & Hazardous & Other Waste(M& TM) Rules 2016 and Environment Protection.

In view of above, your application for authorization is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981, Hazardous & Other Waste 2016 and Bio-Medical Waste (Management and Handling) Rule, 1998.

Please note that operating of unit without valid consent of the Board is an offence and attracts further stringent legal action as deem fit under the provision of various Environmental enactments, which may please be noted.
