Sub: Cancellation of application of registration under the Plastic Waste Management Rules, 2016.

Ref: 1) Your application No. MPCB-PLASTIC_MANF_RC-0000000131 for grant of Registration under PWM rules 2016 received through Sub Regional Officer, MPCB, Kalyan III.

WHEREAS, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for as Recycler for Recycling of plastic waste vide reference No.1.

AND WHEREAS, Government of Maharashtra has published Maharashtra Plastic and Thermocol Products (Manufacture, Usage, Sale, Transport, Handling and Storage) Notification, 2018 which entails the ban on all plastic and thermocol products except for certain items subject to conditions specified thereof.

AND WHEREAS, Sub-Regional Officer, Kalyan III reported that your industry was observed to be closed in the year 2019 and 2021 during their visit.

AND WHEREAS, you have obtained consent to establish dated 13.03.2019 for recycling of plastic scrap and mfg. of plastic granules (Dry process without washing activity.), however, you have obtained/ applied for Consent to Operate from the M.P.C. Board.


AND WHEREAS, it is noted that the validity of sub-letting from Maharashtra Industrial Development Corporation (MIDC) to your industry's plot no. H-48/1A, Additional MIDC, Murbad area has already expired on 30.10.2020.

AND WHEREAS, in line with the decisions taken in meeting of the committee constituted for deciding guidelines/ examination for issuance of Registration to Producer/ Recycler/Brand-owners under Plastic Waste Management Rules, 2016, your application was put up before the competent authority for further decision in your case and it was decided to issue Cancellation of registration application for above non-compliances.

In view of the aforesaid, your application for grant of registration is hereby **cancelled** under the provisions of the Plastic waste Management Rules, 2016 and you are hereby directed to:

1. Re-apply for the Consent to Operate to the M.P.C. Board and Registration for Plastic to the M.P.C. Board under Plastic Waste Management Rules, 2016.
2. Submit valid sub-letting letter from MIDC to the M.P.C. Board

You are hereby directed to not to carry out operation activities without aforesaid requirements, failing which the Board will have no option then to initiate further legal action against you, which please note.
