**WHEREAS**, you have made application for the grant of authorization under rule 18(7) of the Hazardous Waste & Other Waste (Management & Transboundary Movement) Rules, 2016 it is mentioned that **“The authorization for transport shall be obtained either by the sender or the receiver on whose behalf the transport is being arranged”**.

**AND WHEREAS**, Board has issued SCN of your application for grant of Authorisation for Hazardous waste Transportation. Board has issued public notice in daily News Paper Loksatta and Indian Express on 25/03/2021 for intimation about hazardous waste transport rule and submission of memorandum of understanding (MOU or MoU) between Transporter and Generator / Receiver of Hazardous waste.

**AND WHEREAS**, Board has issued SCN for **“Non submission MoU between Transporter & Generator/ Receiver of Hazardous Waste”**. You have failed to submit reply to the Show Cause Notice issued.

**Now Therefore**, your application for grant of authorization vide no. MPCB-HW\_TRANSPORT-0000000325 & 326 for transportation of Hazardous Waste is hereby refused as per Hazardous Waste (Management & Transboundary Movement) Rules, 2016. As you have not submitted **“MoU”** in spite of giving sufficient opportunity.

If you are aggrieved by this order, you may prefer on appeal as per provision in the Hazardous Waste (Management & Transboundary Movement) Rules, 2016 within 30 days' time the date of receipt of this letter.

You may prefer to an appeal in Form 12 under provisions of Rule 24 of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 to the Appellate Authority, against refusal order passed as per provision under Section 6(4) of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of this refusal order.
