Sub: Cancellation of application of registration under the Plastic Waste Management Rules, 2016

Ref: 1) Your application No. MPCB-PLASTIC_MANF -0000000766 for grant of renewal of Registration under PWM rules 2016 received through Sub Regional Officer, MPCB, Amravati-I.
2) Minutes of 8th Meeting of Committee constituted for decision on grant /refusal of registration dtd 1.10.2020 and subsequent approval on office note in April,2020.

WHEREAS, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 as Producer for mfg of compostable surgical & medical disposables vide reference No. 1.

AND WHEREAS, you have obtained two separate consent to operate on the same plot for manufacturing of i) delivery kits, disposable gloves, personal health care kits and equipment, hospital ware and garments etc, valid upto 31.10.2022 ii) surgical drapes valid upto 30.9.2022.

AND WHEREAS, during scrutiny of your application for registration following lacunae were observed:

1. You have not obtained/ submitted copy of proper Consent to Operate for manufacturing compostable material.
2. You have not submitted copy of CIPET certificate on biodegradability of your compostable material as per PWM (amendment) rules, 2018

AND WHEREAS, in line with the decisions taken in meeting of the committee constituted for deciding guidelines/ examination for issuance of Registration to Producer/ Recycler/Brand-owners under Plastic Waste Management Rules, 2016, your application was put up before the competent authority for further decision in your case and it was decided to directly issue cancellation of registration application and ask the industry to reapply after obtaining amendment in consent to Operate for mfg of compostable material for relevant purpose as per Maharashtra Plastic Notification, CIPET report for bio-degradability of their product.

NOW THEREFORE, you are hereby directed to show cause as to why your application for registration shall not be cancelled under the provisions of rule 13 (10) of the Plastic Waste Management Rules, 2016?

In view of the aforesaid non-compliance, your application for grant of registration is hereby cancelled under the provisions of the Plastic waste Management Rules, 2016 and you are hereby directed to reapply after obtaining amendment in consent to Operate for mfg of compostable material for relevant purpose as per Maharashtra Plastic Notification, CIPET report for bio-degradability of your product and to stop your operation activities forthwith, failing which the Board will have no option then to initiate further legal action against you, which please note.
