Sub : Final Refusal of Consent under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Waste (M& TM) Rules 2016.

WHEREAS, Ministry of Environment, Forest & Climate Change, Govt. of India has notified, Water (Prevention and Control of Pollution) Act, 1974 for prevention and control of water pollution and the maintaining or restoring of wholesomeness of water and Air (Prevention and Control of Pollution), Act, 1981 for prevention, control of air pollution.

AND WHEREAS, Ministry of Environment, Forest & Climate Change, Govt. of India in exercise of the powers conferred u/s 6,8, & 25 of Environment (Protection) Act, 1986 has notified the Bio Medical Waste Management Rules, 2016 and amended Rules, 2018 which is subsequently amended from time to time.

AND WHEREAS, Maharashtra Pollution Control Board is the Prescribed Authority for the enforcement of Bio-Medical Waste Management Rules, 2016 as amended from time to time.

AND WHEREAS, it is also obligatory on the part of every occupier generating Bio-Medical waste to obtain consent to operate and BMW authorization under Rule 8 of the said Rule, by making application in Form - I to the prescribed authority accompanied by a fee as prescribed by the State Government of Maharashtra.

AND WHEREAS, you have applied for only BMW Authorization vide above reference and Sub-Regional Officer has processed and submitted the said application to this office and after scrutiny, non-Compliances/discrepancies in the application as follows.

1. You have not applied for combine consent & authorization.
2. You have not submitted valid membership of CBMWTF for disposal of BMW.
3. You have not submitted certificate of Bombay Nursing Home Registration.
4. You have not submitted land ownership document.
5. You have not submitted details effluent treatment system with its disposal.
6. You have not submitted exact commissioning date of Hospital as there is Nov. 2017 in application & as per membership of CBMWTF it is Jan.2018. Clarify the issue with documents.
7. You have not paid the requisite fees for Authorization. Same fees access will be given as per reply of SCN, pl. note.

AND WHEREAS, Board has issued Show Cause Notice vide ref (2) above under Clause B of Sub Section (4) of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974 for refusal of application and directed to submit your reply.

AND WHEREAS, it is noted that, after communication and given sufficient time period, you have failed to submit your satisfactory compliance and reply to above notice which shows your negligent attitude towards compliance of Provision of the Water (P& CP) Act, 1974 and the Air (P& CP) Act, 1981, and Environment (Protection) Act, 1986 read with Bio Medical Waste Management Rules, 2016 and amended Rules, 2018.

NOW THEREFORE, your application for authorization is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Waste 2016.

Please note that establishment/operating the Hospital without consent/Authorization of the Board is an offence and attracts further stringent legal action as deem fit under the provision of various Environmental enactments, which may please be noted.
