## A. General conditions of authorisation:

- 1. The authorised person shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
- 2. The authorisation shall be produced for inspection at the request of an officer authorised by the State Pollution Control Board.
- 3. The person authorised shall not import, store and trade in the Other wastes other than those wastes permitted through this authorisation.

- **4.** Any change in the storage location shall be reported to the State Pollution Control Board.
- **5.** The authorised person shall intimate the State Pollution Control Board regarding closure of the facility.
- **6.** The waste which gets generated during storage and trading of imported Other wastes shall be treated and disposed of as per prevailing regulations.
- 7. The importer shall bear the cost of import and mitigation of damages if any caused during the process of import, storage and trading.
