WHEREAS, your factory is located in the "Pollution Prevention Area" under the Water (Prevention & Control of Pollution) Act, 1974 under the Air (Prevention & Control of Pollution) Act, 1981 Authorization under Bio Medical(M and H) Rules 1998 ad The Hazardous and Other Waste ( M & TM) Rules, 2016 followed by further amendments made thertein from time to time.

AND WHERE it is obligatory on your part to obtain combined consent and authorization under Bio Medical Waste (M and H) Rules, 1998 and consent TO Establish and consent to operate under section 25 and 26 resp of the Water (Prevention & Control of Pollution) Act, 1974 under the Air (Prevention & Control of Pollution) Act, 1981 Authorization under the Hazardous and Other Waste (M & TM) Rules, 2016, it is obligatory on your part to comply the same.

AND WHEREAS, you had applied for grant of authorization vide above ref (1) and Sub Regional Office Pune 1 has processed and submitted the said application to this office. During process this office has noticed-

1. You have not submitted valid certificate of BNH registration.
2. You have not submitted the valid membership certificate of CBMWTSDF.
3. You have not submitted details of BMW disposal and its annual report.
4. You have not submitted details of ETP/STP with its design and drawing.
5. You have not submitted details of autoclave.
6. You have not submitted CA certificate.
7. details of ETP/STP with its design and drawing.
8. You have not submitted BG of RS/- 1.40 lakhs, imposed vide previous authorization.

AND WHERE, Board has issued Show Cause Notice vide above ref (3), under clause B of Sub Section (4) of section 25 of the Water (prevention and control of pollution) Act, 1974 and under Bio Medical Waste (M and H) Rules, 1998, For refusal of authorization and directed to submit your reply.

AND WHEREAS, it is noted that, after communication and given sufficient time period you have failed to submit your satisfactory compliance and reply to above notices which shows your negligent attitude towards compliance of Bio Medical Waste provision of the Water (P & CP) Act, 1974 and 31 A of the Air (P & CP) Act, 1981 & Hazardous and Other waste (M & TM) Rules 2016 and Environment Protection.

In view of above, your application for authorization/consent is hereby Refused under section 27 of the Water (Prevention and Control of pollution) Act, 1974 and section 21 of the air (Prevention and Control of Pollution) Act, 1981 and Hazardous and Other Waste (M and TM) Rules 2016, Bio Medical (M and H) Rules 1998..

Please note that, operating of hospital unit without valid authorization/ consent of the Board is an offence and attracts further stringent legal action as deem fit under the provision of various Environmental enactments, which may please be noted.
