Sub: Refusal of application for registration under Hazardous Waste Transportation under Hazardous Waste & Other Waste (Management & Transboundary Movement) Rules, 2016.

Ref: 1) Your application No. MPCB-HW_TRANSPORT-0000000712 dtd. 09-06-2023 received from the Sub Regional Officer, MPCB Raigad-II.
2) Show Cause Notice issued on dtd. 06/05/2024.

WHEREAS, As per the rule 18(7) of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016, it is mentioned that **“The authorization for transport shall be obtained either by the sender or the receiver on whose behalf the transport is being arranged”**.

AND WHEREAS, Board has issued public notice in daily News Paper Loksatta and Indian Express on 25/03/2021 for intimation about hazardous waste transport rule and submission of memorandum of understanding (MOU or MoU) between Transporter and Generator / Receiver of Hazardous waste.

AND WHEREAS, Board has received your application for grant of Authorisation for Hazardous waste Transportation under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016. We have issued SCN for non-payment of Rs. 5000/- for online payment for HW Transport authorisation as per Circular dated 30.1.2024, but you have not given the reply of SCN & not submitted/ paid authorization fees of Rs. 5000/- till date. Hence, we may refused your application.

NOW THEREFORE, you are hereby directed to show cause as to why your application authorization for HW-Transportation shall not be refused.

You are hereby called upon to submit your reply to this Show Cause Notice within a period of ten days from the receipt of this communication, failing which, the Board will have no option than to issue refusal letter for application, please note.
