Ref: 1) Your application No. MPCB-PLASTIC_MANF_RC-0000000405 for grant of Registration under PWM rules 2016 received through Sub Regional Officer, MPCB, Navi Mumbai II.

WHEREAS, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for as Recycler for Recycling of plastic waste vide reference No.1.

AND WHEREAS, Government of Maharashtra has published Maharashtra Plastic and Thermocol Products (Manufacture, Usage, Sale, Transport, Handling and Storage) Notification, 2018 which entails the ban on all plastic and thermocol products except for certain items subject to conditions specified thereof.


AND WHEREAS, Show Cause Notice was issued to you on 14.07.2020 regarding non-submission of MSME Udyog Aadhar certificate. Also, query letter was issued by SRO Navi Mumbai II dated 05.07.2021 regarding non-submission of environmental statement and Bank guarantee of Rs. 25,000/- as per consent condition, to which you have not submitted reply and are not complied.

AND WHEREAS, your Consent to Operate and plastic registration application is for the address "S.no:-23, Hissa No:-1, House No:-1076,vill:- Pimpri, Gausia market, Dhaisar mori, Taluka & Dist:-Thane", but you have submitted Udyog Aadhar certificate for different address given as "H. No. 111, Dharna, Panvel, Raigad, Maharashtra, 410 208".

AND WHEREAS, in line with the decisions taken in meeting of the committee constituted for deciding guidelines/ examination for issuance of Registration to Producer/ Recycler/Brand-owners under Plastic Waste Management Rules, 2016, your application was put up before the competent authority for further decision in your case and it was decided to issue Cancellation of registration application for above non-compliances.

In view of the aforesaid, your application for grant of registration is hereby **cancelled** under the provisions of the Plastic waste Management Rules, 2016 and you are hereby directed to: re-apply for Registration for Plastic to the M.P.C. Board under Plastic Waste Management Rules, 2016 and submit valid Udyog Aadhar certificate at the time of application.

You are hereby directed to not to carry out operation activities without aforesaid requirements, failing which the Board will have no option then to initiate further legal action against you, which please note.
