Sub: Final Refusal of Consent under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Wastes (M& TM) Rules, 2016.

2) Show Cause Notice under Clause B of Sub Section (4) of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974 for refusal of consent vide letter no.210326-FTS-0189, Dtd 26/03/2021.

WHEREAS, your hospital is located in the "Pollution Prevention Area" under the Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under the Hazardous and Other Wastes (M & TM) Rules, 2016 read with Bio Medical Waste Management Rule, 2016 followed by further amendments made therein from time to time. And it is an obligatory on your part to obtain consent of the Board and to provide adequate air and water pollution control systems to control the pollution from your activity.

AND WHEREAS, you have applied for grant of combine consent and authorization vide above reference (1) under the provision of Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under the Hazardous and Other Wastes (M & TM) Rules, 2016.

AND WHEREAS, Sub-Regional Officer has processed and submitted the said application to this office with non-compliances/discrepancies in the application as follows.

- 1) You have not submitted valid Bombay Nursing Home Certificate of Registration.
- 2) You have not submitted details of Sewage Treatment Plant as you only submitted proposal for installation.
- 3) You have not paid requisite consent fees as fees showing pending.

AND WHEREAS, Board has issued Show Cause Notice vide ref (2) above under Clause B of Sub Section (4) of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974 for refusal of consent and directed to submit your reply.

AND WHEREAS, it is noted that, after communication and given sufficient time period, you have failed to submit your compliance and reply to above notices which shows your negligent attitude towards compliance of Provision of the Water (P& CP) Act, 1974 and the Air (P& CP) Act, 1981 & Hazardous & Other Wastes (M& TM) Rules, 2016 and Environment Protection.

In view of above, your application for Consent is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Wastes Rules, 2016.

Please note that Establish / operating of unit without valid consent of the Board is an offence and attracts further stringent legal action as deem fit under the provision of various Environmental enactments, which may please be noted.
