In case of violation, the Maharashtra Pollution Control Board will revoke / suspend the Registration and consent granted by the Board and will also take further legal action.
- 3) You shall comply with the directions given by the Municipal Corporation / Municipal Council i.e. local body.
- 4) This certificate of registration stands automatically cancelled, if any of the conditions stipulated above are found to be violated.
- 5) You shall apply for renewal of registration at least one hundred twenty days before the expiry of the validity of the registration certificate.
