

WHEREAS, you have applied for grant of Authorization for import of Ferrous & Non-ferrous Metal Scrap-10000 MTA (Part-D of Schedule-III) for trading activity under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board has issued SCN for refusal as referred at sr. no. 3. vide reference (3) above in which asked to submit the 1)Import Export License of Foreign Trade. 2)MoU with actual end user. 3)Consent to Operate issued by the State Pollution Control Board.

AND WHEREAS, you have only uploaded IEC certificate and you have failed to submit the MoU with actual end user and Consent to Operate issued by the State Pollution Control Board even sufficient & reasonable oppportunity given for the submission of the same and in the absence of the desired information, the Board is unable to take decision about grant of authorization.

NOW THEREFORE, your application for grant of Authorization is hereby refused under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 within 30 day's time from the date of receipt of this refusal order.
