WHEREAS, this office is in receipt of your application for grant of Amendment of BMW CCA Consent to Operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, this office has issued consent for 24 beds and you have applied for increasing bed capacity from 24 to 30. And submitted BNH Certificate with 30 beds. Needs to apply for BMW CCA. As per circular for Amendment dated 25.08.2025, application is recommended for refusal of amendment if approved. Submitted Plz.

In view of above, considering the above noncompliance, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981. You are hereby directed not to take any effective steps towards expansion and operation of the unit without permission of the Board and apply for BMW CCA with expansion, else Board will initiate legal action as per the provisions of Environmental enactments.

If you are aggrieved by this order, you may prefer on appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 days' time from the date of receipt of this letter.
