WHEREAS, this office is in receipt of your application for grant of Consent to Establish (AMMENDMENT) under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, the Board Office has issued Consent to Establish vide UAN No. MPCBCONSENT-0000094301, dated 30.03.2021, wherein the Consent to Establish is valid upto the commissioning of the unit or for a period of five years, i.e., up to 30.03.2026. You have applied for an amendment to the Consent to Establish for extension of its validity by one year, i.e., up to 30.03.2027. However, the same cannot be considered and is not eligible under amendment category as per the Board's Circular dated 25.08.2025.

AND AS, your application is not according with the Board's Circular dated-25.08.2025

In view of above, your application for grant of amendment in obtained Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
